What's in the River?

Summer is here and everyone is headed to the water! Whether that is a lake, river, or ocean it may not be as clean as you think. Impaired waterways can look clear but are places where the water is contaminated by pollutants. These pollutants can be chemical, litter, nutrients, and so much more. Here in Lexington County, our biggest pollutant is fecal coliform- AKA animal and human waste! This is caused by septic failures, natural wildlife, and dog waste left on the ground. When the bacteria levels get very high, DHEC declares the river to be a TMDL site. TMDL means Total Daily Maximum Load, therefore when a site is declared a TMDL, it has consistently surpassed the maximum amount of bacteria allowed in the water. This means the TMDL sites in Lexington exceed the maximum amount for fecal coliform- gross! Luckily the County and LCSC regularly tests the waters and is working to prevent any new TMDL sites.

How to Get Involved in Trash the Poop

The LCSC has many programs to help prevent more bacteria from entering our waterways. Trash the Poop is our biggest campaign educating the public on the harms of leaving pet waste on the ground. The LCSC attends the Dog Days for baseball games promoting this campaign as well as offering free pet waste stations to neighborhoods! How to Wash Your Car the Eco-Friendly Way

Despite what many believe, it is actually worse to wash your car on pavement versus on grass. Since the storm drains in Lexington County lead straight to the closest waterway, any water and soap would enter



straight into the drains. Pavement is an impermeable surface where water will flow right off into the storm drains. Grass acts like a sponge and absorbs the soapy water before it can reach the street. The LCSC encourages everyone to live by the slogan: "Only rain down the drain" mean-

ing even water from a hose or bucket shouldn't enter the storm drains. Ideally the most eco-friendly way to wash your car is to bring it to a local car wash, where the water gets treated; but if you are wanting to do it yourself, choose to do so on your yard. Using the natural cleaning supplies will also help to keep the drains as clean as your car!
