>>> MS4 PERMIT MINIMUM CONTROL MEASURES

MCM1: Public Education & Outreach

Municipalities are required to provide educational material about stormwater to a variety of audiences. The primary purpose of the material is to provide the audience with information about stormwater and how their actions may impact it.

MCM2: Public Participation

Municipalities are required to provide an opportunity for the public to participate in the development and/or implementation of their stormwater management program at least once a year.

MCM3: Illicit Discharge

Municipalities are required to find and eliminate sources of non-stormwater from their storm sewer system. This is a proactive approach that requires systematically looking at the system for these sources and removing them.

MCM4: Management of Construction Site Runoff

Municipalities are required to have an ordinance from management of stormwater discharges from construction sites that disturb one or more acres of land. The ordinance should include sediment and erosion control measures.

MCM5: Management of Post-Construction Site Runoff

Municipalities are required to address stormwater runoff from new development and redevelopment that disturb one or more acres of land. This aims to manage stormwater where it falls and to retain it on-site. This encourages the use of lowimpact design techniques and green infrastructure.

MCM 6: Good Housekeeping

Municipalities are required to implement good housekeeping practices in all operations such as vehicle maintenance, buildings, and infrastructure. The development of pollution prevention plans are required for waste management.

CONGAREE CREEK WATERSHED

IF YOU ARE HAVING ANY OF THE FOLLOWING PROBLEMS, YOUR SEPTIC SYSTEM MAY NEED TO BE REPAIRED.



- Damp/soggy areas in the yard during dry weather, near the drainfield or tank
 - Sewage odor near drainlines or tank
 - Areas of the yard with bright green/spongy/ lush grass, even during dry weather
 - Discharging untreated wastewater to the ground surface
